VESTA CALLS FOR MANDATORY MASK POLICY, WORKLOAD, OPTION 4, HAND SANITIZER FOR ALL CLASSROOMS

FSA campaign

We are holding out hope that our new minister will make the right decision and cancel the FSAs this year and into the future. For this year, the FSA has been postponed to January, but as teachers, we know that the possibility of a standardized test in the context of this year is even less meaningful and accurate an indicator of student learning than ever. The BCTF has released updated FSA campaign material and information for parents on the BCTF portal. Please remember you can hand this material directly to parents and through students if sealed and addressed to the parents.

New Education Minister

Our new Education Minister, Jennifer Whiteside has been in the role for a couple of weeks now, meeting with BCTF President, Teri Mooring already and two additional meetings scheduled in the near future. Minister Whiteside met this morning with the BCTF Executive Committee and expressed an appreciation for the work teachers have done and acknowledged the challenges of working on the front line of a pandemic. She committed to keeping lines of communication open.

The EC raised the profile of several issues including reporting, communication of school exposures, provision of data and the need for increased health and safety processes. The BCTF has produced two briefs to the new Minister that collate and inform the Minster about teachers' priorities.

Failures to Fill

Please continue to send completed <u>failure to fill forms</u> to jody@vesta.ca. The information we are learning from these communications reflects the staggering loss of service to students and impact on teacher workload is widespread. We will continue to collate and provide this information in our advocacy with the district.

Assessment and Reporting

VESTA continues to work with the district to clarify the expectations. As you consider your responsibilities heading into reporting in January, keep in mind the following:

- Option 4 was not intended by the district as remote instruction, rather as a check in to keep students connected to schools for their eventual return. The fact that the district did not modify the format when it became clear that it would be continuing for the term does not change the responsibility of teachers. They have provided a paragraph to be used for Option 4 students
- if work was submitted by Option 4 students, teachers should consider carefully whether they evaluate or report on it
- Teachers whose programs were disrupted due to failure to fill (non-enrolling staff) may not have been able to complete the assessment required in a regular year.
- You cannot report on something you did not teach


