#### BCTF public survey and upcoming Advertising Campaign

As part of the planning for a March Public Education Ad campaign, the BCTF has done some polling of the general public on matters related to education. It affirmed much of what we already know:

- The public places the voices of teachers above all other groups in trustworthiness – why it's important to talk with parents about educational issues!
- There is a high level of support for a mandatory mask mandate
- The public supports reduced class sizes, additional teachers and expanded support for students with special needs
- There is broad public understanding that teachers' workload has been increased by COVID, and that teachers are doing all they can
- There is an increasing awareness of the multiple and broader role that schools play in our communities

Your voice matters. The public trusts teachers and understands that we are working through hard times, and that your work makes a difference.

#### **Provincial Health and Safety**

We understand that the provincial K-12 Health and Safety Guidelines will be revised near the start of February. When we have information about the content and changes to that document, we will be sure to communicate those out to members. VESTA is continuing to advocate for the full expenditure of the provincial and federal COVID grants to support remote learning and school safety.

The team will be talking with the employer (BCPSEA) and government representatives on improvements to the Provincial Bargaining structure, the replacement of Best Efforts with a meaningful process, the 1% at the top of the grid in year 2, and securing prep time for Adult Educators and some secondary teachers.
