Full Range of PSA Conferences for October 23, 2020 - Excellent Choices for Self-Directed Professional Development

Given the current COVID-19 pandemic situation, the BCTF's Provincial Specialist Association Conferences, on the October 23, 2020 PSA day, will be held online. VESTA and the BCTF recognize the importance to all members for access to quality, teacher-led professional development, such as offered by the Provincial Specialists Associations.

Each PSA is running its own unique conference, and teachers will be able to register for their chosen PSA conference as normal. Many PSAs have also decided to offer two streams of core sessions, one being facilitated by the BCTF in addition to their own PSA programming.

VESTA members can access the unspent funds from 2019/2020 in their school-based Professional and Staff Development Fund (8114) for reimbursement of PSA Conference Registration fees.

Complete a plan for Self-Directed Professional Development; examples can be found in the VTF/VSB Professional Development Handbook on the VESTA site. Forward your plan to your School Pro-D Chair. Then, after attending the Conference, submit your receipt and reimbursement form.

Join teachers from around the province and explore a professional issue that interests you.

Assessment of Option 4 students

The requirements for teachers is set by <u>Ministerial Reporting Order</u>, as determined by the Ministry of Education. The VSB does not have the ability to change or modify the reporting requirements. It's a real challenge that there is no sitting government right at the time that teachers are seeking clarification on assessment requirements and other aspects of the K-12 Restart Plan.

At this time, students accessing the Option 4 transitional program are receiving a significantly different educational program than those who are attending in-class instruction and many teachers have justified concerns looking ahead to the reporting. The BCTF and VESTA are working with the Ministry and the District to provide clarification as soon as possible.

VESTA has been assured by the district that the Option 4 program is not remote learning, it is a transition back to school. Our equity concerns aside, we agree that teachers cannot report on subjects they did not teach, and if evaluation was not possible, neither is reporting. We are advocating for a statement to be included on report cards similar to the Spring indicating a modified program was chosen and that reporting will necessarily be incomplete.

Transfer of TTOC credit

TTOCs in continuing or temporary contracts on November 15 of the current school year can transfer TTOC experience to your salary increment placement if you are not at the max pay step and you have a minimum of 85 hours of TTOC practice (as displayed on your pay advice).

You can apply for the request of transfer on Peoplesoft and it will take effect January 1, 2021. If you have questions, you can email skuan@vsb.bc.ca
