Success at the Labour Relations Board

Yesterday's decision by the LRB was welcomed by teachers across the province. You'll recall that in early October, the BCTF sought intervention from the Labour Relations Board on the haphazard and inconsistent implementation of the K-12 Health and Safety guidelines. In part, this is due to the fact that the existing processes can be lengthy and that some of the same issues were arising in multiple worksites and districts.

The key components that members need to know about are as follows:

- It is in effect as of Monday, November 16
- We still need to keep using the local processes (school based and district JOHS, grievance) where appropriate
- A set of troubleshooters has been assigned to work on an expedited basis (including evenings and weekends) to address consistent or repetitive problems
- Clarification on the enforceability of ministry and district plans
- LRB review of district plans for compliance
- Strengthening and increasing collaborative role of provincial Steering Committee

Please continue to check your BCTF email for updates and information on this important victory. One of the factors that we are most pleased about is that the decision does not limit the use of the established process to Health and Safety matters, which we believe may potentially assist in addressing Workload issues, Medical Accommodations and other issues related to COVID operations in school districts.

Teachers and VESTA have been raising concerns through our JOHS committee and grievances, and we'll need to keep doing that. The LRB decision won't solve all of our problems and we'll need to demonstrate we've used the local processes available, but please be assured that VESTA will be availing ourselves of this process as appropriate.

Please plan to attend the Staff Rep Assembly on November 17 for updates on this and other Health and Safety matters.

VESTA's work with Provincial and Regional Bodies

This week, VESTA President, Joanne Sutherland, met with the provincial Steering Committee to raise concerns about issues facing VESTA members, and has continued to meet with the Health Authority to improve processes in schools around enforcement and reporting of confirmed COVID cases.

We are working to establish greater transparency around school exposures and any transmissions, and to determine proactive measures in case the model is required to change – i.e. an equitable, sustainable remote learning option, should such a need be required.

At the BCTF Rep Assembly, VESTA Local Reps helped to carry motions including:

- Sharing of expenditures of Provincial and Federal COVID grants
- Investigation of the impact on student learning of COVID measures
- Investigation on the physical and mental health of staff and students
- Review and report on the efficacy of the K-12 Restart Plan

BCTF face shields and masks
